President's Update

Our club is doing well! Our core membership is holding steady and our show events are doing great. This year we had sectional meets in all three sections with 8 point shows overall in 5 districts. Thanks go out to everyone who worked to hold and attend our events. As always, our members had a good time at the events and people took notice of our great club and group of people.

We had a great club election this year with nearly a full slate of officers on the ballot and numerous nominations for judges. It was especially noteworthy that we had many people step up to take on roles in the club. There was even some lobbying as people aspired to hold roles. This is a far cry from some years in the past where we had to go out and beg people to hold office and judge. We had a good number of our members vote in the election and a number of close votes. For the roles without nominations, several people accepted appointments to the open District Director roles.

I am especially pleased to report that we had several volunteers to take on our Secretary / Treasurer role. Chuck has done an outstanding job over the last 18 years and the AHA owes him our deepest thanks. Greg Bliven won the role and I have been in contact with both Chuck and Greg. We have started shifting club business to Greg and we have also created a number of check lists to help ensure a smooth transition.

This year I appointed a committee to review our current Master Breeder rules and recommend any changes required in light of changes in the hobby over the last few decades. I was very impressed with the level of passion and enthusiasm of the committee members. It looks like everyone is mostly happy with the program but we may see some minor tweaks to help support smaller districts and tidy up administrative changes over the years.

Special thanks are in order for many of our members who stepped up to help the club this year; Bob L for accepting the Central VP role and coordinating the first Central Sectional in many years. Our Master Breeder update committee.

Everyone who accepted appointments to roles and accepted nominated for club service. This coming year I would like to see our membership increase. Let's all work to be more evangelical and "sell" our breed and our club to potential new members. This could look like having "Join the AHA" forms available in our judging areas to purchasing a years' membership for new people who buy birds from you. We also need to work hard to raise more helmets. In the East there is a definite demand for "good" birds and we are having to turn potential new members and breeders away. There is a lot of background interest in helmets and with a little work we can really drive our club even further ahead!







Change the wording in the outstanding breeder of the year award rule to clarify the original intent of the 2004 revision. As worded, the award would almost exclusively be given to a MFC breeder as they routinely have the most total points. This proposal will change the wording to state the Outstanding Breeder of the Year will be awarded "by variety". This change will be retroactive to the 2008 show year. (Members may request recognition back to the 2005 show year on a case by case basis)

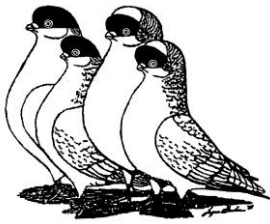
2. *Outstanding Breeder of the Year:*
