Necessary Changes

The AHA is one of the most organized and well planned specialty clubs in the NPA. The club rules are well documented with clear intentions set out in the preamble of all the documents. Lately we have found that there are a few gaps in consistency but realistically the AHA guiding principles are sound and well understood. There has been much debate about potential clarifying rule changes. This may be helpful but I would suggest that the club look even broader at the club rules and structure. If changes are made, go big and do it once and be done with it. In reviewing and digitizing the AHA documents I saw a consistent theme of minor changes sporadically over the years. While these changes were generally well intentioned, it seems that the piecemeal nature of the changes lead to ambiguities which are the subject of recent discussions. Also consider club structure, do we really need out long list of Directors and Officers? The current officer list has 22 officer positions. If all the offices were filled, at current membership levels, approximately 1 in every 4 members would be an officer. That is a top heavy organization. Maybe it would be better to just have the sectional VP's versus a lot of directors? There could be other options, but I think the club would be far more nimble, decisive, and action oriented with less positions. The people in key roles could be expected to work hard, get things done, and then rotate out to share the work load. Next I think about show reports. The system has worked well in the past but let's face it, you need to use a computer or be a mathematician to calculate points. Then copy your form in triplicate and send it to 3 different people. Is it any wonder that few reports are completed? I suggest the forms could be simplified, set out a fixed amount of points for district, sectional, and national meets. If a threshold of exhibitors and birds are met, then the points are a given. Yes, I know that in theory our math was intended to reward bird count, number of exhibitors and etc. However in today's word, I am not really sure those incentives are producing birds at the shows. Maybe have the forms sent just to the bulletin editor or website where the secretary, point's director and others can pull from the bulletin or download what they need. There have been recent discussions about people's behavior. Maybe a code of conduct section could be added to set out expectations for all members. I'm sure there are other things that can be addressed as well. The AHA Constitution, By-Laws and Master Breeder program fill 20 pages, not counting several pages of records of revisions. Maybe there is just too much overhead in the system. My suggestion would be for a committee to look at the breadth of club rules and trim them down. Very simple very clear "bullet point rules" could be created that maintain the intent and principles that have served the AHA very well over the last 50 years. In today's realities, I think simplicity and clarity are king. If you address rule changes be comprehensive, clear, and short.

Secretary's Report

I've heard complaints about the frequency of the bulletin and the amount of content in them. Guess what people, if you don't send anything in, we don't have anything to send out. Am I supposed to send a 2 page document out, one page being the financial report and the other being the join the AHA Form? I also don't want to hear how things were so great in the 70's and how it has declined since then. Guess what, I was born in the 70's and had nothing to do with the decline, the numbers are higher today than when I took the job. If you aren't going to help be part of the solution then you don't get to complain about it. 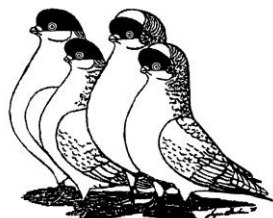
